SUBJECT:	PLANNED DOWNTIME FOR COURT ONLINE SYSTEM MAINTENANCE

1. PURPOSE

- 1.1 The purpose of the circular is to inform the Office of the Chief Justice (OCJ) internal & external stakeholders of the Court Online planned application maintenance scheduled to take place on Friday, 17 January 2025.

2. BACKGROUND/ MOTIVATION

- 2.1 The Court Online application is a cloud-based digital platform that interfaces Case Center application, which is aimed at providing online case initiation, case management and evidence presentation to ensure optimised court proceedings.
- 2.2 The planned maintenance is to upgrade the current Case Center application to the latest available version, which will result in improved communication between Case Center and Court Online. This will in turn result in a more stable, responsive, and reliable application for all users.
